

Be a Player Escort at the Emirates Cup – Terms and Conditions

These terms and conditions (“Terms and Conditions”) set out the basis on which you can participate in the competition to win the chance to be a Player Escort at the Emirates Cup match and accompanying tickets (the “Competition”). By entering the Competition, you accept these terms and conditions in full. If you do not accept these terms and conditions, you should not enter the Competition and you will not be eligible to win the prize. Entry is via online form submission only at: <https://www.arsenal.com/juniorgunners/competitions/2324-emirates-cup-playerescorts> (the “Website”).

COMPETITION PERIOD: The start date for entries is 6 July 2023 at the time the Competition goes live on the Website (UK time) (“Start Date”). The closing date for entries is 16 July 2023 at 23:59 (UK time) (“Closing Date”). Entries received after the closing date will not be entered into the Competition.

TO ENTER: To enter the Competition, you need to visit <https://www.arsenal.com/juniorgunners/competitions/2324-emirates-cup-playerescorts> and fill in the registration form with all required information by no later than the Closing Date.

ELIGIBILITY: Entry is open to parents and guardians on behalf of paid Junior Gunners members aged 7-13 years only. Only one (1) entry per Junior Gunners member is allowed.

As the parent or guardian, you must agree to these terms and conditions in full. Winners may be required to supply a completed parental/legal guardian consent form in accordance with Arsenal’s directions in order to claim their prize.

Employees of The Arsenal Football Club Limited (company number 109244) (“Arsenal”) or members of their immediate families are not eligible to enter the Competition.

No purchase is required to enter but you will require email and internet access to enter the promotion. No refund may be claimed for any expenses incurred relating to the use of an email account or internet connection for the purpose of entering the Competition.

PRIZE: Two (2) winners will each be Player Escorts at the Emirates Cup match between Arsenal and AS Monaco currently due to take place at Emirates Stadium on Wednesday 2 August 2023 at 6:00pm (the “Match”) and will each receive one (1) adult and one (1) Junior Gunner general admission tickets (two (2) tickets in total per winner) to the Match (the “Prize”). Player Escorts will accompany the Arsenal and AS Monaco first team player(s) onto the pitch at Emirates Stadium before the Match kick-off.

The winner(s) must each be accompanied by a parent or guardian to the Match. The Prize is non-transferable and no cash alternative will be offered.

The Prize does not include personal expenditure, transport costs and other incidental costs other than those specifically included. Where applicable to the Prize(s) or parts of the Prize(s), Arsenal’s terms and conditions at <https://www.arsenal.com/ticket-membership-terms> and <https://arsenaldirect.arsenal.com/termsAndConditions> shall apply.

Arsenal reserves the right to substitute the Prize (or any part of it) for a prize or prizes of equivalent or greater monetary value if this is necessary for reasons beyond its control. There is no cash alternative to the Prize (or any part of it) and unless agreed otherwise in writing the Prize is non-refundable and non-transferable. All costs and expenses not included within the Prize are the responsibility of the

winner(s).

Third party terms and conditions apply to parts of the prize where applicable.

SELECTION OF WINNER: Two (2) winners will be picked at random from all eligible and correct entries received between the Start Date and the Closing Date.

The winner(s) will be contacted using the contact details provided on entry within 72 hours of the Closing Date. The Prize and further details in respect of the Player Escort opportunity shall also be provided to the winner(s) in advance of the Match to which the Prize relates.

If the winner(s) cannot be contacted or does not respond to confirm details for delivery of the Prize and to accept their role as Player Escort within 14 days, an alternative winner will be selected at random from the remaining eligible and correct entries.

PUBLICITY AND PERSONAL DATA: If the winner is aged 18 or over, the winner agrees to take part in reasonable publicity relating to the promotion and the promoter and Arsenal may use the winner's name and image and his/her comments relating to the Competition and/or the Prize for future promotional, marketing and publicity purposes in any media worldwide without notice and without any fee being paid.

Details of the winner's name and county will be available on request for one month after the closing date by writing to Arsenal (including providing a stamped self-addressed envelope and stating the name and closing date of the promotion) at the address set out below. Arsenal will use entrants' personal details for the purposes of administering the Competition and awarding the Prize. By entering, all entrants warrant and undertake that they are the legal and beneficial owner of all intellectual property rights in their entry (including all images and text submitted by the entrant as part of the entry process), that their entry is their own original work and does not infringe any third party rights.

All entrants warrant that their entry does not infringe English law.

All entrants hereby waive and agree not to assert (and warrant that all individuals featured have waived and agreed not to assert) any moral rights in and in connection with their entry.

All entrants agree to do such other things and execute such other documents as are reasonably requested of them by Arsenal in order to allow Arsenal to use their entry for the Permitted Purposes.

Arsenal reserves the right to pass on any images which cause it concern to the relevant authorities.

OTHER IMPORTANT INFORMATION: Entries must not be submitted through agents or third parties. No responsibility can be accepted for lost, delayed or incomplete entries, or for electronic entries or winning notifications that are not received or delivered (for any reason including as a consequence of communication or network failures). Any such entries will be deemed void.

Arsenal reserves the right to withdraw or amend the promotion or these terms and conditions if circumstances outside its reasonable control make this unavoidable.

Entries must be strictly in accordance with these Terms and Conditions. Any entry not in strict accordance with these Terms and Conditions will be deemed to be invalid and the Prize will not be awarded in respect of such entry. Arsenal reserves the right to verify the eligibility of any entrant and to exclude any entries which it believes to be invalid or in breach of these Terms and Conditions.

Arsenal's decision is final in all matters relating to the Competition (including the Prize) and no correspondence will be entered into.

Except in respect of death or personal injury resulting from any negligence of Arsenal, to the maximum extent permitted by law, neither Arsenal nor any of its officers, employees or agents shall be responsible for (whether in tort, contract or otherwise):

any loss, damage or injury to you and/or any third party or to any property belonging to you or any third party in connection with the Competition and/or the Prize (including the winner's receipt or use of the same), resulting from any cause whatsoever; or

any loss of profit, loss of use, loss of opportunity or any indirect, economic or consequential losses whatsoever and howsoever caused.

GOVERNING LAW AND JURISDICTION: Please note that this agreement is governed by English law. This means that your entry into the Competition and any dispute or claim arising out of or in connection with it will be governed by English law. You and Arsenal both agree that the courts of England and Wales will have non-exclusive jurisdiction in connection with any such dispute or claim.

SPIRIT OF THE PROMOTION: If you attempt to compromise the integrity or proper operation of the Competition by cheating or committing fraud in any way, Arsenal reserves the right to render your entry invalid, seek damages from you and ban you from participating in any of their future competitions.
