Win Emirates Cup tickets for a 4-person family to Arsenal v AS Monaco - Terms and Conditions

These terms and conditions ("Terms and Conditions") set out the basis on which you can participate in the competition to win tickets for a 4-person family (2 adults, 2 children) to the Arsenal v AS Monaco Emirates Cup match (the "Competition"). - 10. If travel is required, it is the responsibility of the prize winner to ensure they have a valid passport and obtain relevant visas and vaccinations for their holiday (and to procure that any family member(s) attending the Match using the winner's tickets have the same).
- 11. Arsenal reserves the right to substitute the Prize(s) (or any part of it/them) for a prize or prizes of equivalent or greater monetary value if this is necessary for reasons beyond its control. There is no cash alternative to the Prize (or any part of them) and unless agreed otherwise in writing the Prize is non-refundable and non-transferable.
