## **Prize Draw Terms and Conditions**

## Win a 'Win the Dog' Plush Toy

These terms and conditions ("Terms and Conditions") set out the basis on which you can participate in the prize draw to win a Win the Dog Plush Toy (the "Prize Draw"). - 8. Arsenal reserves the right to substitute the Prize(s) (or any part of it/them) for a prize or prizes of equivalent or greater monetary value if this is necessary for reasons beyond its control. There is no cash alternative to the Prize (or any part of them) and unless agreed otherwise in writing the Prize is non-refundable and non-transferable. - 9. Third party terms and conditions apply to parts of the Prize where applicable.

- 10. **SELECTION OF WINNER**: Five (5) entrants will be picked at random from all eligible and correct entries received between the Start Date and the Closing Date (the "Winner(s)").
- 11. The winner(s) will be contacted using the contact details provided on entry within 72 hours of the Closing Date. If a winner cannot be contacted or does not respond to confirm details for delivery of the Prize within 14 days, an alternative winner will be selected at random from the remaining eligible and correct entries.
- 12. Unless otherwise notified by Arsenal, the Prize will be delivered to the winner within 30 days of confirmation of the winner's address for delivery of the Prize.
- 13. **PUBLICITY AND PERSONAL DATA:** Details of each winner's name and county will be available on request for one month after the Closing Date by writing to Arsenal (including providing a stamped self-addressed envelope and stating the name and closing date of the Prize Draw) at the address set out below.

- 17. Entries must be strictly in accordance with these Terms and Conditions. Any entry not in strict accordance with these Terms and Conditions will be deemed to be invalid and the Prize will not be awarded in respect of such entry. Arsenal reserves the right to verify the eligibility of any entrant and to exclude any entries which it believes to be invalid or in breach of these Terms and Conditions.
- 18. Arsenal's decision is final in all matters relating to the Prize Draw (including the Prize) and no correspondence will be entered into.
- 19. Except in respect of death or personal injury resulting from any negligence of Arsenal, to the maximum extent permitted by law, neither Arsenal nor any of its officers, employees or agents shall be responsible for (whether in tort, contract or otherwise):

This means that your entry into the Prize Draw and any dispute or claim arising out of or in connection with it will be governed by English law.
